Please see the attached eligibility criteria for contesting to Executive Committee as per the provisions of Memorandum and Articles of Association.

ELEIGIBILITY CRITERIA FOR CONTESTING TO EXECUTIVE COMMITTEE

(Extract from the Memorandum and Articles of Association)

- 16.2: The 5 posts of Office bearers namely President, Vice-President, Secretary, Joint Secretary and Treasurer and 5 Executive committee members shall be filled up by the election and nominations can be filed for the said post only by eligible members
- 16.3 (i) : All Donor, Life and Regular members with 3 years standing are eligible for contesting for the Executive Committee except for the post of President. As a convention the president will be elected from Donor members only.
- (ii) Any member proposed to be the member of the EC should be on the rolls of RVCS as a member for a minimum period of three years as on the date of AGM.

A member cannot hold of the office of EC member for more than two terms.

(iii) Any EC member to be the Office bearer in the EC in the capacity of Vice -President, Joint Secretary, Treasurer should serve for a minimum of one term in EC

A member cannot hold the Office bearer for more than two terms either in the capacity of Vice-president, Joint Secretary and Treasurer or jointly of the above.

(iv) Any Office bearer proposed to be the President or Secretary should serve EC for minimum two terms.

Any Office Bearer in the capacity of President (or) Secretary can not hold office for more than two terms either as President or Secretary.

16.4: The candidate should not have been found guilty by any Disciplinary Committee or any such Committee legitimately instituted to look into Members misbehavior.

He /She should have no dues at the time of nomination.

18.4 Each candidate shall be eligible to file his/her nomination for only one post in the committee.

Candidates seeking election for any position in the Executive Committee shall be proposed and seconded respectively by one member each among Donor, Life and Regular members, who are at least 3 years standing as a member in the Society and who are in dues and who are not convicted in any criminal case or moral turpitude.

One eligible member can only propose or second one nomination. If he proposes or second more than one, those nominations will be treated as invalid.

23: At Annual General Meeting or Extraordinary General Meeting or franchising vote for election of Executive members, every Donor/Life/Regular member, who is not in arrears shall have the right to cast one vote in person.



Rules & Regulations of the Election procedure:

- The cost of Nomination form is Rs 500 /- (Rs Five hundred only) which is not refundable.
- 2. The caution deposit shall be paid along with nomination as follows:

President & Secretary: Rs 5,000 (Rs Five thousand only)

Vice- President / Joint Secretary / Treasurer : Rs 3,000 /- (Rs Three thousand only)

Executive member : Rs 2,000 /- (Rs Two thousand only)

In case of withdrawal of nomination within scheduled time as per the election notification, 50 % of the caution deposit will be refunded.

If the contesting member does not secure a minimum of 10 % of the polled votes, the caution deposit will be forfeited,

Nomination Box will be opened by the Election Officer in the presence of at least five RVCS members on 11.06.2025 at 5.00 PM and prepare the list of contestants also along with the nominations received through RVCS email.
